TERMS AND CONDITIONS OF RENTAL

GB Geotechnics (Australia) Pty. Limited, hereinafter called GBGA, agrees to rent the equipment specified in Schedule 2 of this Agreement to the company or person whose name and address appear in Schedule 1 of this Agreement, hereinafter referred to as RENTER, under the following terms and conditions:

- 1. **Equipment Rented:** GBGA hereby rents to the RENTER, and the RENTER hereby hires from GBGA, the Equipment as set forth in Schedule 2 of this Agreement.
- 2. **Rental Rate:** The rental rate for the above equipment shall be as per Schedule 3 of this Agreement. RENTER shall pay GBGA either prior to delivery, or for approved customers within fourteen (14) days of receipt of invoice issued to the RENTER by GBGA. The estimated rental cost is based on estimated delivery and return dates, final invoiced amounts will be calculated based on actual dates of delivery and return. For long term rentals (greater than 1 month) invoices will be submitted monthly. Freight costs shown in Schedule 3 are estimated and may vary dependent on freighting location and urgency of delivery, freight costs shown in the invoice issued to the RENTER by GBGA will supersede the amount shown in Schedule 3. Prices are exclusive of any domestic or overseas taxes and/or duties. All quoted prices are exclusive of GST and will be charged at 10% for hire within Australia.
- 3. **Rental Period:** The rental shall commence from the time the Equipment leaves the office of GBGA either by pick up by the RENTER or freight shipment and shall terminate upon its return to the office GBGA. For freight shipments leaving the office of GBGA rental charges will commence the day after the equipment leaves. If the equipment arrives back to the office of GBGA after 12 pm, either by freight shipment or pick up by the RENTER, full rental charges will apply for that day. Part days are not accepted.
- 4. **Insurance:** The RENTER is responsible if any equipment is stolen or damaged whilst in use or in transit. A Certificate of Currency adequate to cover the replacement cost of the equipment to the value specified in Schedule 2 must be held by the RENTER for the entire rental term.
- 5. Ownership: The equipment is, and shall at all times remain the exclusive property of GBGA.
- 6. **Warranty/Breakdown:** GBGA warrants that the equipment set forth in Schedule 2 is in operational condition at the time of dispatch. Should equipment breakdown during normal operation, GBGA will endeavour to repair or replace the equipment in a timely manner. In the event of equipment breakdown, the RENTER must notify GBGA as soon as possible so that suitable replacement/repairs can be organised.
- 7. **Maintenance:** Proper care and maintenance of the equipment during its operation is the responsibility of the RENTER. When not in use and during transit all equipment must be correctly packed in the containers supplied. Equipment which is returned to GBGA in poor condition due to abnormal wear and tear will be cleaned and repaired at the RENTER's expense. By signing schedule 4 of the rental form the RENTER acknowledges that they are learned of the safe operation and storage of the equipment, and that any costs for repairs required due to damage caused by misuse or mishandling will be to the RENTERS account.
- 8. **Alterations:** The RENTER may make no alterations or repairs to the equipment without prior approval from GBGA.
- 9. **Operation/Interpretation:** The RENTER acknowledges that they are experienced on the operation of the equipment and interpretation of the results. If required training on the efficient operation of the equipment can be provided by GBGA prior to rental at an additional cost. GBGA is not responsible for the method of operation of the equipment, the results obtained or the interpretation.
- 10. Overseas Rentals: There will be a 15 per cent surcharge for all equipment rentals that are shipped offshore Australia. Costs for any customs handling, duty and other additional charges that might apply to overseas shipment and return of the equipment will be the responsibility of the RENTER. The issuing of documents and declarations necessary for the overseas transport of the equipment will be organised by GBGA on consultation with the RENTER.
